In case of setting the payment obligation(s) as specified above, this Agreement constitutes an acknowledgement of debt which may be used in any potential recovery/collection procedure.

In the event of theft or loss of the Subscriber Card, there are 14 days available from the date of the blocking request submitted at the Service Provider to get the Subscriber Card replaced and reactivated without losing the discount or incurring a penalty payment obligation. The replacement of the card is subject to a fee, based on the Service Provider's current tariffs for services provided on the mobile telephone network.

Only the owner of a lost or stolen telephone set may request that it be disconnected and connected back again.
