TELEKOM’S ADMINISTRATOR AND ITS RIGHTS:

Acts on behalf of the Customer or as the Customer’s delegate to make legal statements on behalf of the Customer in Magyar Telekom’s customer service channels (Online systems, Call Center, E-mail Contact Center, Telekom shops) in connection with the services and products provided by Magyar Telekom. The administrator may assign additional access and procedural rights on Magyar Telekom’s online portal to persons acting on behalf of and designated by the Customer, determine their level of access rights, and may order, cancel and change the order for equipment, subscription and services on behalf of the Customer, sold by the Service Provider, through any customer service channel; initiate changes to all services and their parameters used under the Customer’s contract with the Service Provider, change the Customer’s contact details communicated to the Service Provider, and act on behalf of the Customer in any customer service or invoice related matters.

STATEMENT OF THE CUSTOMER RELATED TO THE AUTHORIZATION OF TELEKOM’S ADMINISTRATOR:

I, the undersigned, as the duly authorized executive officer of the Customer specified above, authorize the above Telekom Administrator to act on behalf of the Customer in full authority with respect to the administrative activities (full-scope Magyar Telekom administration) specified in this document. This authorization is valid until its withdrawal. The person(s) authorized to legally represent the Customer shall notify Magyar Telekom in writing of the withdrawal of the authorization without delay. The Service Provider shall not be held liable for any legal consequences related to the failure or improper notification. The Service Provider shall not be liable if the Telekom Administrator exceeds the scope of the authorisation herein or otherwise acts contrary to the interest of the Customer. The Customer is fully responsible for the activities of the Telekom Administrator.

OTHER STATEMENTS MADE BY THE CUSTOMER IN CONNECTION WITH THE TELEKOM ADMINISTRATOR’S ACTIVITIES:

I agree that the Service Provider may use the above contact details to inform me about electronic communications services and other services and offers already agreed between the Customer and the Service Provider. I accept this method of information and acknowledge that notifications sent to the contact details may contain personal data and confidential information. I further authorise the Service Provider to accept orders, requests and contract modification proposals from these contact details as set out in the Business GCC.

I accept that the Service Provider is not obliged and is not entitled to verify the procedural rights of the person authorised in this statement as “Telekom Administrator” and the additional users provided by the Administrator. I further agree that in the case of requests, notifications and other communications received from the contact details provided above, Magyar Telekom is not obliged to investigate the notifier’s eligibility and the validity of the notification!

I agree that the Customer shall immediately notify Magyar Telekom of any changes in the contact details. The Customer shall be liable for any legal consequences or damages arising from the failure to notify changes of the contact details.

By signing this authorisation and statement I acknowledge that prior to signing this authorisation and statement my statements and data provided to Magyar Telekom will be amended or supplemented as set out in this authorisation and statement.

The administrative data will take effect upon filling in and returning the statement within 15 working days of receipt by Magyar Telekom Plc. Please return the statement containing your data by post to our customer service. (1276 Budapest, Pf. 1400)

The contact details provided by the Customer may be changed freely by the Telekom Administrator, however, the Service Provider is not entitled to verify them. Any change to the Telekom Administrator’s identity may only be effective upon submission of a new duly signed Authorization and statement or waiver to the Service Provider.
